## 25 April 2022 Minutes

Meeting was called to order at 1907 hrs. by the Commander.

Roll of Post officers was called with all officers present except the excused absence of the Jr. Vice and Executive members Les O'Neal and Jerry Sauerwein.

No guests in attendance.

The March meeting minutes were read with motion to accept with one correction by Doug Jameson and seconded by Robert Thomas. Minutes approved by membership.

The Membership Report was given with Department showing 139 of 162 for 85.8%. National is showing us at 145 out of 162. Bill Martin indicated he was sending in 3 or 4 cards to Department the week prior to the meeting.

The Finance Officer provided a breakdown of the post's accounts with \$8,121.34 in the General Fund with \$2,000 set aside for Insurance, \$35 for the Haven, \$66.50 for Gifts for the Yanks and \$229.50 for the Honor Guard with an additional \$3,258.99 in Savings. Rich Gaebel motioned to accept the finance report subject to audit. Seconded by Doug Jameson. Membership approved.

Veteran Affairs – The next meeting of the St. Clair VAC will be April 26<sup>th</sup> at 7 p.m.

Community Patriotic Observances – The Belleville Memorial Day Parade will be on 30 May ending at Walnut Hill Cemetery where the ceremony will be held. The Commander will talk to the city to see what our roll will be.

Honor Guard – The Commander ordered 10 bib scarfs for the Honor Guard. Rich Gabel presented the new bugle gadget that plays 10 tunes. He stated they would have training at 1000 on Wednesday at the Improvement Center. There would be flags, a mock casket and rifles that the trainer will bring from Maryville. Carol Davis volunteered for the Honor Guard.

Americanism – No report

Boy Scouts – The Commander will be attending the Department Committee meeting in Bloomington on May 7<sup>th</sup>. Two candidates in the entire sate put in applications for the Legion Scholarship. Three additional applications subsequently showed up.
