

Charles A. Woodford American Legion Post 2007



August 25, 2025

Meeting was called to order at 1905 hours by the Commander.

Roll of Post officers was called with all officers and Executive Committee members were present with the absence of Senior Vice Andrew Dunham, Sgt at Arms Gary Stacy and Executive Committee Members Mary Monett and Robert Thomas.

The Sergeant at Arms announced two guests in attendance: Al Dotson and Clevon Holmes.

No special presentations.

The Commander asked if there were any changes to the previous meeting minutes. No corrections noted, minutes stand as presented.

The **Membership Report** was given showing the Post has 91 of 158 paid members for 2026.

Finance Report – The Finance Officer reported we had a checking account balance of \$8,082.72 available with and an additional \$723.34 in savings. We also have repurchased our \$3,000 short-term Certificate of Deposit. A breakdown of funds held for the various programs was also provided. A motion was made by Steve Duff to accept the report subject to audit. Seconded by Todd Herzog. Membership approved.

Poppies – Poppy Day on August 9th took in over \$443. The next Poppy Day is October 18th at the Greenmount Commons Lowes.

Veteran Affairs – The next meeting will be held August 26th at 7 p.m. at the VAC at 19 Public Square in Belleville.

Community Patriotic Observances – POW/MIA Day is September 19th. There will be a ceremony at VFW Post 805 in O'Fallon at 10 a.m. There will be lunch after the ceremony, all are welcome. There will be a Veteran's Day ceremony at the Square. The Commander will be working with the Village of Swansea to see if they have anything planned and what we can do to help. Patriot's Day is Sept 11th. PSOP will have donuts available 10 a.m. sponsored by the VFW.

Honor Guard – Rich has contacted the VFW to start a joint team. The Commander stated that State Bill 0220 passed amending the Military Leave Act to allow paid employees up to 8 hours of leave for members of veteran organizations who participate as part of an honor guard at military funerals.
