December 18, 2023

Meeting was called to order at 1907 hours by the Commander.

Roll of Post officers was called with all officers and Executive Committee members present with the exception Finance Officer Steve Duff.

As the winner of last year's award, we get to vote on the next year's recipient. The Department newsletter and a package of program material sent by the Department were also received. - 4. Rich Gaebel informed the Commander that he had turned the Post bugle over to Honor Guard Co-Chair, Doug Jameson while he is gone for the month of January. It will be stored at the VFW.

Memorial to Departed Members – No news of any Post member's passing. The Commander informed us that Lifetime Legion member, Chuck Ridge of the New Baden Post had departed after a long illness. The New Baden Post will be doing a walkthrough during his viewing on Thursday. The viewing would be from 4 p.m. to 7 p.m.
