Meeting was called to order at 1908 hours by the Commander.

Roll of Post officers was called with all officers and Executive Committee members present except for the excused absence of the Sr. Vice, Executive Committee Member Kori Bookman and Sargent at Arms Gary Stacy and the unexcused absence of Executive Committee Member Robert Thomas.

The **Membership Report** was given with 147 out of 162 paid members for the new membership which puts us at 90.74%.
