

# Charles A. Woodford American Legion Post 2007



July 28, 2025

Meeting was called to order at 7 p.m. by the Senior Vice Commander.

Rollcall of Post officers was conducted. All officers and Executive Committee members were present with the exception of excused absences of the Commander (Jim Page), Adjutant (Dave Devine), one of our Sergeant-At-Arms (Gary Stacy), and one Executive Committee Member (Robert Thomas).

The Sergeant-At-Arms (Kenny Green) reported there were no guests in attendance.

**Review and Acceptance of June 2025 Meeting Minutes.** The June meeting minutes were emailed to all members who have provided us an email address, and the minutes have been posted to our website https://www.swanseapost2007.com/. The Senior Vice Commander did not ask members whether there were any changes to the June meeting minutes that needed to be made.

The **Membership Report** was given by the Junior Vice Commander (Bill Martin). Our Post has 46 of 158 members who have paid the 2026 membership fee. The 2026 American Legion membership renewal campaign started July 1, 2025.
