- 2. Rich Gaebel stated that the Honor Guard needs white gloves, preferably with a rubberized gripping surface in order to handle the weapons during cold weather. The Commander had a form available. We need to order them in time for the 7 December ceremony. A motion was made by Rich to purchase 6 pairs. Seconded by Doug Jameson with an amendment to purchase 2 medium and 4 large pairs. Membership approved.
- 3. It was proposed to have another fundraiser at McAlister's in January. Tabled for discussion during the December meeting.
