## 24 September 2018 Minutes

Meeting was called to order at 1906 hrs by the Commander.

A request for funds from the Daniken Tree Farm's Trees for Troops program was briefly discussed and tabled.

New Business – The 1<sup>st</sup> 9/11 memorial ceremony would be held at the Swansea Firehouse. Members were invited to participate.

Comments on the memorial for a departed legionnaire were made. Post members performed the ceremony at Charlie Woodford's wake. The Post received a note of appreciation from Charlie's daughter.
